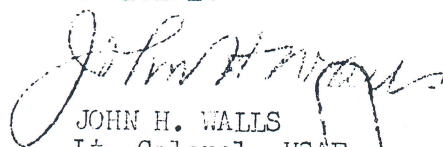


8. Pursuant to authority contained in paragraph 3 b, AR 35-1495, and Section V, WD Circular 209, 1947, the following-named individuals, who hold ratings as parachutist, are placed on parachute jump status while assigned to duty as members of a pararescue team.
