PATTLE ISLAND (16-32N 111-36E). THE SOLDIER WAS INJURED BY HE WAS INJURED
SH PNEL THE RIBHT LEG, WHICH HAD BECOME BADLY INFECTED. NO
MEDICAL FACILITIES WERE AVAILABLE ON THIS REMOTE ISLAND, NECESSI
TATING HIS EVACUATION. CROWN 7 AND JOLLY GREENS 31 AND 21
